## Feedback from the MAG

- Overall positive feedback from the MAG
- Some input on potential focus (education for youth) and a specific suggestion for additional emphasis on government lead by example (energy audit of the governor's mansion)
- If CC TWG thinks setting goals is a priority – then should suggest that as an option along with the basis for goal – quantification will be done by other TWGs
- MAG suggested separating criteria from policies for several TWGs
- MAG provided approval of the CC TWG catalog and implicit consent to proceed with evaluating policy options

## Next Steps For TWG

1. Develop initial GHG inventories and forecasts
  - Sector-specific TWGs are currently reviewing their sections of the I&F
  - CC TWG will consider I&F as part of the options in the catalog
  - I&F will be finalized with consideration of ADEC recommended improvements
2. Identify possible GHG mitigation options ✓
3. Identify initial priorities for evaluation
  - Aggregation
  - Prioritization
  - Criteria – externalities and feasibility

## For Today's Call – Clarifying and Aggregating Options

- CC TWG catalog currently contains 10 broad categories and 65 options
  - Content, focus, and potential audiences of some options overlap and vary
- CC TWG will condense catalog and aggregate options through clustering exercise and discussion
  - CC TWG will consider possible groupings at the category level and the option level
  - Can group between and within categories
- Purpose of aggregating is to streamline catalog
  - Maximize effectiveness of potential options
  - Simplify and focus prioritization and selection of priorities
- CC TWG will then discuss criteria and prioritize options

## Selecting Priorities for Analysis

- Goal is to choose top ~10 options to propose to the MAG
- CC TWG will select priorities for analysis using prioritization tool plus discussion based on criteria
- These are priorities for analysis, not recommendations for option implementation
- TWG will then develop selected options further into detailed policy:
  - Description, Design objectives, timing, implementation strategies
  - Related programs and policies in place
  - Quantification of estimated emission reductions and costs, where possible
  - Description of uncertainties, feasibility issues, additional benefits and costs
- The TWG will bring these recommendations to the MAG in September

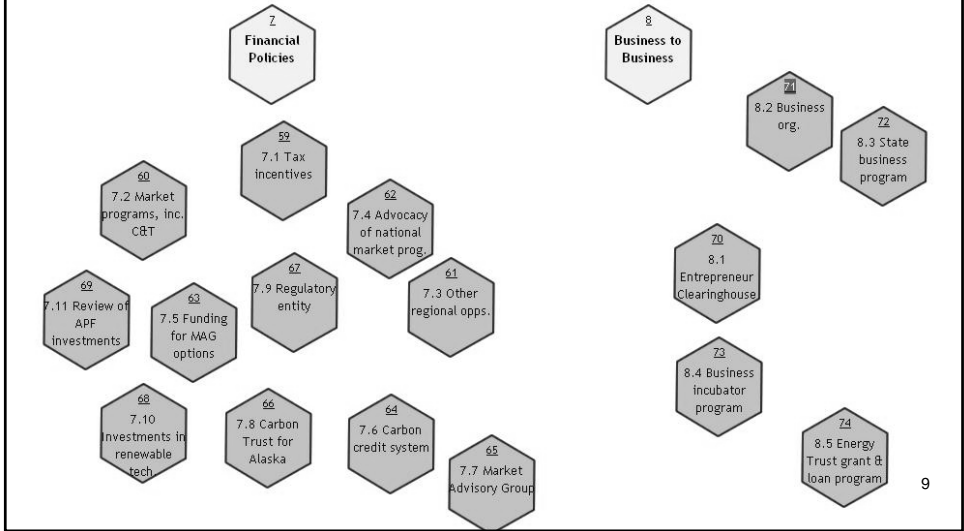

# Aggregating Approach

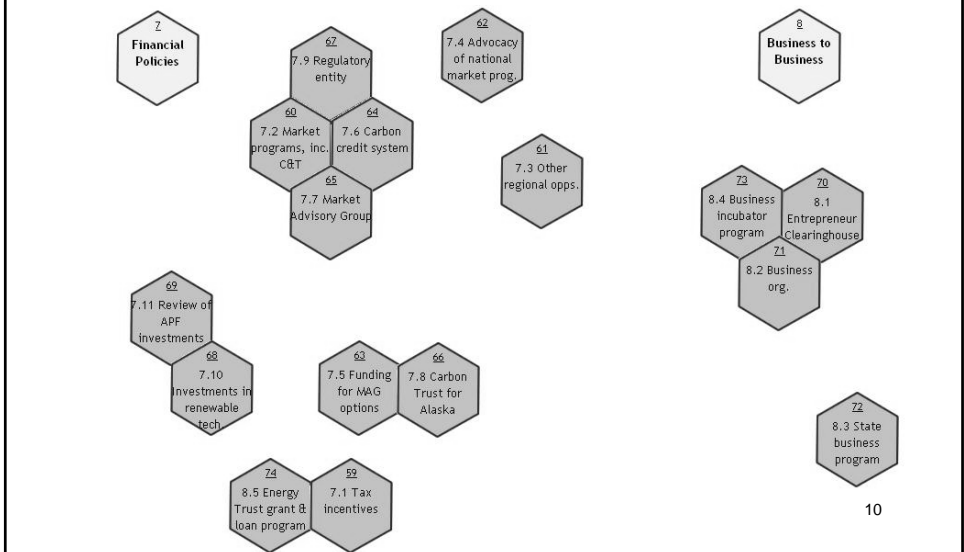
## Step 1: Consider All Options

## Mitigation Decision Criteria

- GHG Reduction Potential (MMtCO<sub>2</sub>e)
- Cost or Cost Saved Per Ton GHG Removed
  - Emissions reduction and costs estimates for CC TWG policy options tend to be qualitative, not quantitative
- Co-benefits
- Feasibility Issues
- Others?

Option No.	GHG Reduction Policy Option	Externalities, Feasibility Considerations	Priority for Analysis
CC-7	<b>FINANCIAL POLICIES</b>		
7.1	Institute tax incentives and disincentives for individuals, as well as public and private entities, to encourage GHG reductions or other financial measures, such as revolving loan funds and grants		
7.2	Pursue other market-based programs, including cap-and-trade*		
7.3	Explore other regional opportunities, both public and private		
7.4	State advocacy of a national market-based system (e.g. national cap-and-trade)
